SOME FREQUENTLY ASKED QUESTIONS:

Q Who is eligible and how will I know about what events to enter?

A Your Rider and/or Horse Day Ticket allows you to compete in Intro, Pre-Novice and Open Pre-Novice, Novice and Open Novice or Intermediate Novice. Riders must be in the calendar year of their 14th birthday to compete at Intro and Pre-Novice level and must be 16 or over to compete at Novice level. Horses/ponies must be 142.2cm or over without shoes (and must exceed 148cm to compete in Novice). All riders that have not reached their 16th birthday must obtain accreditation from their Junior Regional Co-ordinator in order to compete in any class. The bi-monthly magazine has full details of all the events open to you.

Q Will my entry be treated the same as a fully registered British Eventing horse and rider?

A Day Ticket entries will have no priority in the event of a ballot (when an event is oversubscribed at ballot date) but full British Eventing members with Day Ticket horses will take precedence over non-members. If you are balloted out or have to withdraw, your entry form will be returned so that you can use your Day Ticket again to make another entry. Full rules on withdrawal are in the Rule Book.

Q I would like to compete on an experienced horse which has British Eventing points - is this allowed?

A Yes, but horses with BE points are restricted to certain classes. Grade III horses (1-20 points) can compete in Open Pre-Novice classes or non-competitively (HC) in normal Pre-Novice and Intro classes. Grade II or I horses (more than 20 points) can compete in Open Pre-Novice and Open Novice classes or non-competitively in normal Pre-Novice or Novice classes. Horses running HC are not eligible for prizes or rosettes.

Q Will I be eligible for prizes?

A Yes. Any Day Ticket entry placed will receive rosettes and prize money or prizes in kind for Pre-Novice just the same as a fully registered horse provided they are eligible (ie not running non-competitively). In Novice classes, prize money will be awarded as normal and points for placings and double clears earned will be credited to the horse if it is subsequently registered.

Q If I win a Pre-Novice section can I continue in Pre-Novice classes?

A Yes - but if you win two Pre-Novice (PN) classes you cannot enter PN again. You can compete at PN level but only in OPEN PN classes. You cannot go back to compete at Intro level.

Q I am a non-member - will I be covered by insurance?

A Your Ticket provides British Eventing insurance cover whilst you are at the event only. Full details of cover are available from British Eventing.

Q If I purchase a Day Ticket and for some reason am unable to use it, do I get a refund? (see Rule Book)

A No refunds of horse or rider Day Tickets will be given except under following circumstances:

- Cancellation of Event after an entry to that Event was made using Day Ticket(s)
- Proof that balloting prevented Day Ticket(s) from being used during the season.
- On production of a vet's certificate demonstrating that the horse was not fit to run at Events at which the Day Ticket(s) were to be used.

If one or more of these circumstances apply, then a refund of 75% of the value of the Day Tickets returned to BE will be given.
